**Terms of Reference:**

1. UTLSC may co-opt two more members from Agricultural Research Organizations, reputed NGOs working in the field of Agriculture, Deputy Commissioners of important districts and leading farmers.
2. The quorum for the UTLSC meeting shall not be complete without presence of representative from the Government of India.
3. UTLSC shall be responsible for sanctioning the projects, under Flexi fund Component under PMDP (MIDH).
4. It shall monitor the progress of the sanctioned projects/schemes.
5. It shall review implementation of the schemes' objectives and ensure that the programmes are implemented in accordance with the guidelines laid down.
6. It shall ensure that no duplication of efforts or resources takes place.
7. It shall ensure commissioning/undertaking field studies to monitor the implementation of the projects.



8. It shall initiate evaluation studies from time to time, as may be required.
9. It shall ensure that there are no inter-district disparities with respect to the financial patterns/subsidy assistance in the projects.
10. The UTLSC shall meet as often as required but shall meet at least once in a quarter.
